- Bridging the Gap John O: 3 yrs ago BTG developed and set in motions a localized pilot correspondence program—the foundation of this program was based on GSO pamphlet F-163. We joined the last year of the pilot, bringing the pamphlet into our county jail and the state fire camp. BTG as a whole, last year in our entire area, received 1,700 requests for our services. We have correspondence with an inmate who will be released in Lake Co. soon.
- Hospitals & Institutions We continue to provide services at the local jail and see approx. 50 inmates monthly. We are facing challenges with renewing our state prison clearances (Fire Camp). New applications, requiring TB tests and live scans as part of the process is seemingly quite arduous—H&I is piloting at San Quentin a Sponsorship opportunity for the Inmates that may open a different possibility for us in the future. Our Sutter Hospital meeting on the 2nd and 4th Wednesday evenings is reading through the Living Sober book. District 13 January contribution to H&I was \$276.78. The whole income for the area of H&I for January was \$83,270.23, Literature expense from that was \$51,109.62 your dollars at work!
